## **Description of Duties / Essential Functions**

Performs duties mostly independently, while under the supervision of the Chairperson of the Education Department. Works toward established goals in the Museum's strategic plan and educational programs in the Museum subject areas of art, anthropology, history, botany, geology, and zoology. Works with staff in the Education Department to coordinate public and school programs of all sizes and with all ages. This includes researching, developing, coordinating, promoting, delivering, and evaluating programs for diverse Museum visitors with consideration of a variety of demographic factors. Responsible for coordinating school programs: developing, promoting, executing, and evaluating on-site and outreach programs for students in PreK-12. Assists with other duties related to the Education Department, including periodically staffing and maintaining the Play Museum (a permanent hands-on exhibition designed for young children); assisting with the development of interpretive materials and exhibitions; overseeing volunteers and interns; and representing the Museum at outreach events. Initiates and conducts research on issues such as education and learning; collects and analyzes educational data for program evaluation using cutting edge techniques; contributes to new knowledge and experiences through the development, execution, and evaluation of educational programs; interprets and presents results for public and scholarly professional audiences; and writes reports and articles based on research for publication in professional publications, museum publications, and popular outlets. Executes highly specialized duties and complex projects that require special expertise and experience with educational programming, an extensive and intensive knowledge base in multiple relevant disciplines; and skills required for educational programming at the level of an individual with a Master's degree with at least 3 years of relevant experience in educational programming in a museum or related environment. Assists the Chairperson of Education, and works with professional staff and volunteers in carrying out disciplinebased educational programming. Responsible for seeking grants from external funding sources, including federal agencies, where nationally recognized expertise and higher degrees are required to be competitive. Performs at a level that reflects national standards and best practices of an accredited museum and brings state, national, and/or international recognition to the Museum. Follows all relevant state and federal laws and abides by professional museum ethics and the ethics of specific program areas and disciplines (education, art, anthropology, botany, zoology, and geology). Participates in relevant professional organizations. Works with senior and subordinate staff in establishing objectives, implementing programs, and conducting evaluations. All curators are responsible for advocating for the Museum and its programs. Performs other duties as assigned by the Chairperson of the Education Department or the Museum Director.

## **Desirable Education, Training and Experience / Minimum Requirements**

Requires a minimum of a M.A., M.S., or M.F.A. in education, museum education, museum studies, or discipline directly related to the Museum's mission, with 3 years relevant experience teaching or coordinating educational programming in a museum or similar environment. Must be proficient in word processing, desktop publishing, electronic database management, and the use of social media. Must have demonstrated experience in development and delivery of museum educational programs and production of educational materials for a museum or similar environment. Must have experience training, supervising and interacting with volunteers. Familiarity with Illinois State Museum content areas required. Participation in state and/or national professional organizations is expected. Previous success in securing grants preferred.
